Acceptance:

Please read this Privacy Policy carefully. Your use of this website ("Site") indicates that you have read and accepted our privacy practices, as described in this Privacy Policy. In addition, please review our **Terms of Use**, which govern your use of this Site.

Information That Ogg Trading Collects:

- a. **Personally Identifiable Information:** Personally identifiable information is information that identifies you or could reasonably be used to identify you personally (such as, but not limited to, your name, address, phone number, or e-mail address). Providing personally identifiable information is voluntary. You may, however, not be able to use the full functionality of this Site if you do not provide certain information.

We collect personally identifiable information that you provide during your use of the Site, including:
